FBCAS Monthly Shelter Statistics Report – October 2025

From October 1, 2025 through October 31, 2025, the overall save rate for FBCAS was 96%. The save rate for dogs was 93% and for cats it was 97%.*

Since August 2018, FBCAS has maintained a 90% save rate for the pets entering our shelter.

- 178 feral/community cats were returned to field as part of our Community Cat Program.
- 11 dogs and 1 cat were returned to their owners through our Return to Owner/Return in Field programs.

Dogs:

- One dog died en route to the shelter.
- One dog in the shelter.
- One dog was humanely euthanized as part of a head to lab bite investigation.
- Two dogs were humanely euthanized due to aggression towards staff and public.

Cats:

- One kitten in foster due to illness/failure to thrive.
- One kitten died in shelter due to illness/failure to thrive.
- Two cats were humanely euthanized due to severe illness/injury.

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
