FBCAS Monthly Shelter Statistics Report – November 2025

From November 1, 2025 through November 30, 2025, the overall save rate for FBCAS was 92%. The save rate for dogs was 91% and for cats it was 93%.*

Since August 2018, FBCAS has maintained a 90% save rate for the pets entering our shelter.

- 72 feral/community cats were returned to field as part of our Community Cat Program.
- 19 dogs and 4 cat were returned to their owners through our Return to Owner/Return in Field programs.

Dogs:

- One puppy was humanely euthanized – failure to thrive.
- Four dogs were surrendered by their owners and humanely euthanized as part of head to lab bite investigations.
- One dog was humanely euthanized due to aggression towards staff and public.

Cats:

- One kitten died in foster due to illness/failure to thrive.
- Three kittens were humanely euthanized in shelter due to illness/failure to thrive.
- One cat died in shelter due to severe illness/injury.
- Three cats were humanely euthanized due to severe illness/injury.

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
